RESOLUTION #17-2

WHEREAS, In October 2007 the National Executive Committee approved Resolution 35, establishing The American Legion Riders (ALR) as a national program to be administered by the Departments and the Posts; and

WHEREAS, The Department of Georgia Executive Committee approved a revised Constitution and By-Laws for the ALR in March 2015 at the Department Spring Conference which was amended by resolution in June 2015 at the Department Convention and by Resolution #16-1 in March 2016 at the Department Spring Conference; and

WHEREAS, Department Commanders have been recognized as Rider-In-Chief of the Department of Georgia American Legion Riders since 2008; and

WHEREAS, The Rider-In-Chief is presented with a rider vest including a back patch and road name; and

WHEREAS, The Past Rider-In-Chief may desire to continue their association with their local American Legion Rider Chapter; now, therefore, be it

RESOLVED, By Post 111 of The American Legion Department of Georgia in regular meeting assembled in Dallas, Georgia on November 1st, 2017, that the Constitution of the American Legion Riders Department of Georgia be amended as follows:

Article IV, Section 6

From: "There shall be no form or class of membership except an active membership, and dues shall be paid as required by the Chapter or by the Department. There are no national dues. Honorary or Associate membership in a Post ALR Chapter is forbidden."

To: "There shall be no form or class of membership except an active membership, and dues shall be paid as required by the Chapter or by the Department. There are no national dues. Honorary or Associate membership in a Post ALR Chapter is forbidden, except for all Past Rider-In-Chiefs (Past Department Commanders), so recognized, since 2008."

Article IV, Section 7

From: "Each ALR member shall establish and maintain membership by being the registered owner of a street legal motorcycle ("two (2) wheeled" or "three (3) wheeled") or be the legally registered owner's spouse or partner within the state of

registration. Additionally, child/grandchild (under 18 years old) of the legally registered owner member is qualified for membership at the same Chapter."


To: "Each ALR member shall establish and maintain membership by being the registered owner of a street legal motorcycle ("two (2) wheeled" or "three (3) wheeled") or be the legally registered owner's spouse or partner within the state of registration, or be a Past Rider-In-Chief since 2008. Additionally, child/grandchild (under 18 years old) of the legally registered owner member is qualified for membership at the same Chapter."; and, be it finally

RESOLVED, That this resolution be forwarded to The American Legion 5th District, Department of Georgia, and upon approval, be forwarded to The American Legion, Department of Georgia for consideration.

This is to certify that the above resolution was approved in the general membership meeting of Post 111 on November 1st, 2017.




