# Asst Director Reports -

**Area 1**: Report sent to State Director – very busy. Many events done to support Veterans. Not able to go into VA hospital, but still did a ride. Raised funds for "Emergency Fund" & "Commander's Project." PGR Missions continue. Director





attended chapter & district meetings. District 10 Director, Robert Wilson asked for assistance for a WWII Veteran escort out of Vidalia. Director Barnette reached out to District 1, and within 2 hours the PGR and Low Country Bikers answered the call to give this veteran all the honors deserved. Will be giving certificates to chapters who participated in special events. Precented certificates of appreciation to the 11<sup>th</sup> district for hosting a special event for the Commander's Project with Chapter 1 as the main participant. They raised \$5,000 in 4 hours! Chapter 178 received a certificate of appreciation for National Vietnam Day.

**Area 2:** Report sent to State Director – Has done lots of work mostly through District 5 which has many chapters. 2 chapters in district 4 sent no reports. No riders in district 3. Received a report for district 5 but have not read it.

Area 3: No Report

Area 4: District 7 lost another chapter. Supported Ellijay with their annual fair. Supported District 10 Loganville ride. District 9, chapter 129 had a few bike nights with great success. I am better since being ill. Will be getting more involved.

#### **DOG Director's Report:**

To date we have had a successful year. Macon had a memorial ride that raised \$22,500. Need to do more recruiting. We are losing many members. We only have 879 ALR members. Called Incoming Director Propst to the podium who will conduct elections.

## **Incoming Director Propst:**

Incoming Commander Bill Simmons and I have had a close relationship through the years and asked me to be the DOG director and I accepted. Thank you, Johnny, for leading the riders this past year. We wish you well!

#### **New Business**

Pending Resolution: Was posted on the website. The Constitution & Bylaws was approved last year, however with one controversial paragraph regarding carrying of weapons. Unknowingly there was another resolution before the National committee. The National Executive Committee's resolve: Resolution 5 (the most current resolution guidelines for American Legion Riders). It was initiated at my Post 70, approved by the Post 70 membership and the 5<sup>th</sup> District.

The Resolve Clause: "Resolve, that the DOG ALR Constitution article 4 section 7 be amended to read as follows: Each ALR member shall establish and maintain membership by being a registered owner of a street legal motorcycle, 2 wheels or 3 wheels or be the legally registered owner of a spouse, partner, life partner or long term relationship within the state of registration or be a past rider in chief since 2008. Additionally, a child, grandchild under 18 years old of the legally registered owner member is qualified for membership at the same chapter."

"Be it further resolved that the DOG ALR Constitution article 5 section 8 stating that: to maintain the image of the American Legion and its programs, ALR members while wearing any American Legion Riders apparel shall not display exposed weapons. This applies when it violates state law, engaging in national events, such as The American Legion Legacy Run, escorting national officers, national convention, and national parade. The use and carrying of ceremonial rifles and weapons should be exempt when traveling or actively participating in funerals, ceremonial details or parades be deleted in its entirety."

That is 2 changes. We are deleting the paragraph concerning the carrying of weapons, reverting to the state law where you may be riding! Be aware of state carry laws especially on the Legacy Run that runs through multiple states or on vacation. Motion to approve – Second – no discussion – Accepted

**Fund Raising:** Continue DOG ALR 50/50, Angel coins (PGR), Cash 3, GoFund Me and Challenge Coin are some ideas that will be considered. Also, need Districts to produce their own fundraiser that benefits their district for Veterans, Children, or the Community. Another possibility is a Gun Raffle 30/30 (30 guns in 30 days) that could potentially could raise \$45,000. We will look into setting up online sales as well.

The Incoming Dept Commander has asked for a commitment from the ALR: \$1,000 for the Oratorical Prize Fund; \$6,000 (sponsoring 10 boys & 10 girls for Boys & Girls State) and \$10,000 for the Commanders Special Project. We will also consider an In-state Ride to support the Legacy/Commander's Project.

Wreaths Across America is our big fundraiser. We receive a rebate back for each wreath sponsored, which we then donate to the Commanders Special Project. Entertain a line item in your budgets for \$300 in wreaths for the Department ALR. Forms are on DOG ALR website.

#### Participation:

Will revisit the event requirements. May go to Area based. Example: District 5 has a project "Veterans Transition from Homelessness" for the past 4 years. District 5 Director will produce a new beneficiary for his project. It will now come with Thea into Area 2. Will continue to do "The Ride Home," Boy & Girls State (requirement may become optional), Conferences & Conventions required. Still looking at mid-winter conference and convention. No change will happen before our contractual agreement with Sonesta Hotel ends in 2025.

The National Commander may come in January 2023 and the National President in October 2022.

An Assistant Director will be assigned to each event that we come up with. Also continue to handle the Vietnam War 50<sup>th</sup> Anniversary Recognition for Vietnam Veterans with GA Department of Veteran Services.
