• Currently we have 43 ALR Chapters in the state with membership of 877. 528 are Legionnaires, 155 are Auxiliary and 194 are Sons of the American Legion. We have added two chapters this year; Post 50, Peachtree City; and Post 500, Savannah. We are working on forming a chapter at Post 154, Tybee Island.





- Sweepstakes ticket sales have been slow. We need a big push the next 30 days or we won't reach the break-even point. We need each chapter to buy at least 10 tickets.
- Wreaths Across America We currently have 442 wreaths sponsored so far. We need to have all money in to WAA
 no later than Monday, November 28. Please be sure to use the DOG ALR sponsorship form. Our group number is

- Due to price and availability, the Executive Committee decided to switch to a one-size fits all ball cap instead of the beret. Director and Assistant Directors: white cap; District Directors: royal blue cap; Staff: burgundy. Caps are now available.

New Business

Director Propst has suggested three additional changes to the Constitution

- 1. Article III Organization; C- Post; Section 2 add a new Subsection a "Additionally, all Chapter ALR members, operators and passengers, must complete and maintain a Member Application/Information Form to be maintained at the Post Home by the ALR Secretary." Motion made, seconded and approved by unanimous vote.
- 2. Article V American Legion Rider Regalia; Section 6 change "beret" to "Ball Cap with ALR logo" in all subsections, add "royal" to subsection b and change "maroon" to "burgundy" in subsection c. Motion made, seconded and approved by unanimous vote.
- 3. Article VI Elected Officers; B Post; Section 1; add new second sentence "Required positions cannot be combined and must be different Chapter members." Motion made, seconded and approved by unanimous vote.
